<u>POLICY NAME</u>: Area C Expense Reimbursement from Cortina Villas Inc. and Canoa Vistas II Inc to Canoa Seca Estates II, Inc.

# EFFECTIVE DATE: 4/22/2020

<u>BACKGROUND</u>: The area on Camino Estelar from Trogon/Huarache to Camino del Sol is known as Area C. Area C is owned and maintained by Canoa Seca Estates II, Inc. This area is shared by a total of three HOAs; CSEII (owner), Canoa Vistas II (CVII) and Cortina Villas (CV). Each HOA has a share in the expenses to maintain this areas.

Area C roadway length is 623 feet long and by 26 feet long or a total of 16,198 square feet.

# POLICY:

#### **Expenses shared equally:**

- 1. Tucson electric monument lighting actual expense
- 2. Improvements to the monument & landscaping near the intersection at Camino del Sol and Camino Estelar to include repair, painting, lighting, palm tree trimming and landscape maintenance

# Expenses pro-rated based on square feet of Area C roads, curbs & sidewalks:

- 1. Annual costs of repair, maintenance & insurance for all of the road, sidewalks & curbs
- 2. Reserves anticipated for road, sidewalk & curb repair, resurfacing and replacement
- 3. Administrative fee of not more than 6%, if charged
- 4. Cost sharing is based on the recorded deed:
  - a. CSEII 65.7%
  - b. CVII 26.3%
  - c. CV 8.0%

# SCHEDULE FOR EXPENSE REIMBURSEMENT:

CSEII will invoice CVII and CV each year on our around mid-December with payment due by Jan 31 of the following year. This invoice is for the actual expenses that year plus road reserve.

Overdue late fees of 10% will be applied on reimbursement not made by Jan 31.
