UPDATES

Steve Christy, Pima County Board of Supervisors, District 4 absent Report given by Tom Berezny, Green Valley Board of Supervisors Representative

- Prosperity Initiative Study gave the county 13 priorities, which will be used to direct county funds. Christy voted
 against it because a board seat was still vacant. Also, there was no input from industry. How this will affect the
 county is still up in the air.
- Transportation Committee has a small surplus because actual bids were under the estimates. Other projects may be started.
- Transportation Committee looking at other revenues sources. Voted against increasing property taxes because Green Valley does not get their share now.

Chief Chuck Wunder, Green Valley Fire District

- New fire station dedication had 800 people tour. Thanks to the community for passing the bonds.
- Minor fender bender calls are up. Be careful driving. So far, no major injuries.
- Over holidays, watch out for kitchen fires and trees fires due to drying out.
- Thanks to donations, 500 kids got Christmas presents this year.

- Scam from UPS asking for more information to deliver your order. Just trying to get credit card numbers.

Mayor Tom Murphy, Town of Sahuarita

- Salvation Army Bell Ringers reached 94% of their goal.
- In January, 400 antique cars will be at Quail Creek Park. Car Nuts will sponsor the event with funds going to support the auto mechanics training at the schools.
- Tucson got rated as the most aggressive drivers...try to keep it out of here.

CEO Scott Somers, Green Valley Recreation

- Canoa Rec Center scheduled to open January 1st.
- Work has started on Del Sol, with it to be completed in late spring.
