UPDATES

Steve Christy, Pima County Board of Supervisors, District 4

- Pima County will encircle the county with an open access network. This will allow "internet deserts" to gain access
 to the internet thorough an underground "spine." The work will be completed in 2028, because archaeological
 areas must be mapped before digging can begin. More information will follow.
- Rumors Tucson Water will increase sewer rates. However, the department is in good financial standing, so it is being opposed. Remember your water usage now through the end of February determines your sewer bill.
- The county's financial situation is being reviewed. Recommendations of good fiscal responsibility are being issued, including hiring freezes, reducing supplies, restricting travel and conferences, and other "non-essential costs." A key change will be an unrestricted fund to cover cash flow or emergency situations. \$5 million is being set aside for this.

Lieutenant Courtney Rodriquez, Pima County Sheriff's Department, absent. Report combined with SAV Commander Doug Kenyon, Green Valley Sheriff's Volunteers

- Scam of month involved police phone calls. Caller says they are from the Sherrif, and they owe money. Sheriff's department will not call on any issue, they just come to your house.
- SAV has been busy in 2023. Giving the going wage rates, SAV saved the county \$850,950.

Mayor Tom Murphy, Town of Sahuarita

- To follow public events in the town, go to their website and click on Parks and Recreation. An entire listing is posted, and a newsletter signup is available.
- On January 27, 400 antique cars will be at Quail Creek Park. Car Nuts will sponsor the event with funds going to support the auto mechanics training at the schools.
- Salvation Army Bell Ringers brought in \$93,000 this season. All of it stays in the local area.
- Union Pacific starting work to coordinate the traffic lights at Quail Creek Crossing. Expected to be done by April.
- The congested intersection of Duvall Mine Road and Abrego is undergoing studies for improvements.

 Resent rumors of the firing of an exercise instructor will be in the GV News. The person was verbally abusive and threatening while conducting GVR business. This was not the first offense and they had been warned. GVR will not tolerate abusive conduct on its premises.

Chris Ackerly – Pima County Deputy Treasurer

- Our county taxes went up due to State Legislature not working the details. Continental School is a K-8 school, sending their high schoolers to Sahuarita. We pay to do so. We were double charged for that service. Corrections in the bill HB2173 is being made to eliminate this, and to "repair the damage."
- Issue in Maricopa County about assessment on rent vs. resident is unique to them. Pima county does not do it that way. Any change to this is your permanent resident, check the county notification. Notify the assessor if incorrect.
- Notification of not paying taxes is a pink letter. Threatens to sell house if not paid. Actually takes 3 years to do that...so pay your taxes. Thus, the threat, not your house, goes away.
