NOMINATING COMMITTEE

Two Board members, President John Sucher and Vice-president Dave Lovell's terms end in March and must be filled in the March election.

The elections for two new board members will be done by electronic ballot prior to the March 1st CSEII Annual Meeting.

We have two excellent candidates who'll be running for the Board: Mike Rass and Alex Verhoogen. There were no further nominations at the January 18th Board Meeting.

As stated in the By-Laws, the CSEII homeowners elect members of the Board, The Board members than determine who will serve as President, Vice-president, Secretary, Treasurer, and Chair of the Architectural Committee.

Below are biographies for the two candidates.

Alex Verhoogen was born in the Belgian Congo and immigrated to the US as a child. He got a BA in Zoology from UC Berkeley in 1963 and graduated medical school from UC Irvine in 1968. After his residency at Sacred Heart Medical Center, he joined the Air Force. Following that, he did an Orthopedic Residency at Duke University from 1972-1976. He had a private practice in Orthopedic Surgery in Spokane, WA from 1976-2008. Following that he worked for MedCentral Professional Foundation in Mansfield Ohio from 2015-2016 and the CORE Institute at Green Valley Hospital from 2015 – 2016. He was Chief of Staff for the Green Valley Hospital/Santa Cruz Valley Regional Hospital from 2015-2021. Alex and his wife, Mary Lee moved to Green Valley in 2014 and to CSE II in 2017. He lives on Tejedor.

Mike Räss received his BA from the University of Wisconsin-Stout in 1978 majoring in Industrial Engineering with a minor in Graphics Arts. In 1988 he received an MS from the University of San Francisco in HR Management. He worked for General Mills, Inc. from 1978 to 1994, in roles that included Research Engineer, Mechanical Packaging and Process Engineer, Process Design Manager, and Director of Technical Services. He joined Kimberly-Clark Corporation in 1995 where he worked (until 2004) in Distribution Logistics, Corporate Training and Development, and as Associate Director of the KC Global Design Center. Simultaneously, he was President of the family business, Rässkin, Inc. (Michel's Bakery & Café) from 1994 to 2003. From 2005-2010, working for The Clorox Company, Mike led a project/package team in Pleasanton CA and Buenos Aries, Argentina. From 2010-2014, working for the Chief Technical officer and EVP Global Consumer Products at Georgia Pacific, Mike was responsible for management skills development of senior leadership, led a team to optimize 4 strategic technology platform groups and led efforts to identify new tangential technologies to invest in. From 2010 - 2020 Mike was on the board of Lakeside Packaging Plus (a not-for-profit organization providing support/skills development to individuals with emotional, learning, and physical disabilities). He was Board president from 2016-2020. Mike is currently chair of the CSE II Monument Decorating Committee and moved to his Garzota home April of 2021. He's a winter resident in Green Valley November through April and spends summers in Wisconsin.

CSEII Electronic Online voting — It's that time of year when our annual membership meeting is approaching. Just like in previous years, we will be using an Electronic Voting system called ElectionBuddy. The election committee plans to send out ballots via email mid-February. Homeowners will have until Feb 28 to complete ballots and submit. Results of the election will be ready to go when we meet at our annual meeting on March 1 at 9:00 A.M.

Things you need to know:

- One email address per household receives an electronic ballot via email if your household has two email addresses please let us know which email should be used, otherwise, we will use the same as the previous election.
- The email message will come from <u>invitations@mail.electionbuddy.com</u>
- A link and an access code unique to your household will be included. Follow the link to reach the ballot.
- Make sure to add the above email address into your contacts so that the ballot doesn't land in your spam folder or be overlooked.
- Please do not unsubscribe or mark as spam the email from ElectionBuddy. If you
 do so, you may not get this ballot or future ones.
- The ballot contains two actions this year.
 - Board of director seats (2) that vacate in March. A Bio for the nominated candidates will be included for your review before voting.
 - Approval of the minutes from 3/2/2023.
- The ballot guides the voter and allows for the voter to vote for the nominee or add a write-in candidate or abstain from voting. The ballot flow helps a voter avoid missing a step so that the vote is valid and counted.
- Voting is by secret ballot or anonymous and can't be seen by anyone else (including the election committee).
- Homeowners without email will automatically be provided a paper ballot.
- In the event a homeowner needs an alternative to online voting, requests for a
 paper ballot should be sent to the election committee at <u>cseii.election@cseii.com</u>
 by February 16.
